**WAIVER OF LIABILITY INDEMNIFICATION AND HOLD HARMLESS AGREEMENT**

I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE THE STATE OF CALIFORNIA, THE TRUSTEES OF THE CALIFORNIA STATE UNIVERSITY, CALIFORNIA STATE UNIVERSITY MONTEREY BAY, UNIVERSITY CORPORATION AT MONTEREY BAY, STATE UNIVERSITY MONTEREY BAY, AND THEIR OFFICERS, DIRECTORS, AND EMPLOYEES (hereinafter collectively referred to as the "RELEASEES") from any and all liabilities, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or minor, or to any property belonging to me or minor, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.
