COURSE OFFERINGS

115 courses were conducted, including 71online and 44 offerings taking place in-person.74 video recordings were produced and posted to OLLI's YouTube channel.

During the pandemic, membership has dropped to just under 800, a 26% decline from our high of 1,065 Members in early 2020.
